





# **2023 EUROPEAN SENIOR LADIES TEAM CHAMPIONSHIP**

## Play suspended by the Committee- Procedure

When play is suspended by the Committee for a dangerous situation, if the players in a match or group are between the play of two holes, they shall not resume play until the Committee has ordered a resumption of play. If they are in the process of playing a hole, they shall discontinue play immediately and shall not thereafter resume play until the Committee has ordered a resumption of play. If a player fails to discontinue play immediately, she shall be disqualified unless circumstances warrant waiving such penalty as provided in Rules.

The signal for suspending play due to a dangerous situation will be the following notes of siren or similar

Discontinue Play Immediately: One prolonged note of siren.

**Discontinue Play:** Three consecutive notes of siren, repeated (players may only complete the hole they are playing).

**Resume Play:** Two short notes of siren, repeated.

## Plan of Evacuation

In case of evacuation of the course, the players must go to the nearest point marked below and wait for instructions. Also, the players must pay attention to return to these collection points.



### Collection Points: 1, 2, 3.

1<u>.-Clubhouse</u>: Hole 1 (tee), 3 (tee), 5, 6, 7, 8, 9, 10, 11 (tee), 16 (tee) 15 (green), 18 (green).

- 2.-<u>Barrier access venue</u>. Hole 1 (green), 2, 3 (Green), 4.
- 3.-Driving Range Hut. Hole11 (green), 12, 13, 14, 15 (tee), 16 (green), 17, 18 (tee).

Toilets on Course. Hole 4th, 15th, 17th and locker by Pro-shop (9 to 10)

<u>Water fountains on Course</u>. Green 6-Tee 7 / Right of the  $12^{th}$  tee.









These Local Rules are in addition to the EGA Local Rules & Terms of Competition 2023 Hard Card:

# LOCAL RULES

#### 1. OUT OF BOUNDS (Rule 18.2)

- Defined by walls, fences, lines, dots and white stakes that define the boundaries of the course.
- If stakes and white lines coexist to mark the out of bounds, the stakes identify it and the lines define it. **Notes:**
- a. The Clubhouse as defined by white posts and adjoining white lines and the wooden railings to the right of tee 1.
- b. Beyond the fence to the right of holes 1 & 4 and the rear of green 6.
- c. The area of the football field to the right of the 8<sup>th</sup> fairway as defined by the wooden fence.
- d. Beyond the fence behind green 8 as indicated by white lines. A ball coming to rest on or beyond the public path behind the 8<sup>th</sup> green is out of bounds, even if it comes to rest on another part of the course that is in bounds for other holes.
- e. The practice ground as indicated by the stakes supporting the protection net. Where the protection net ends, the boundary is defined by white stakes and adjoining white lines.
- f. A ball that crosses a boundary going to lie on another part of the course is out of bounds.

#### 2. ABNORMAL COURSE CONDITIONS (Rule 16)

- a. Immovable Obstructions
- Staked trees and trees supported by sleepers/supports are integral parts of the course and relief under Rule 16.1 is available **ONLY** from the stake/sleeper or support, NO free relief for the tree.
- All concrete and tarmacadam (asphalt) roads are immovable obstructions.
- All other pathways are INTEGRAL PARTS OF THE COURSE unless white lined.
- Relief for animal holes is restricted **ONLY** to the lie of the ball or area of intended swing. No free relief for interference in the player's stance.

#### b. Ground Under Repair (GUR)

• If a player's ball lies in the general area cut to fairway height or less and there is interference from exposed tree roots the tree roots are treated as GUR. The player may take free relief under Rule 16.1b. **But** relief is not allowed if the tree roots **ONLY** interfere with the player's stance.

#### 3. INTEGRAL PART OF THE COURSE (No relief without penalty)

All non-asphalted or non-concreted paths (including those covered with gravel).
